



COVID-19 POLICY

As of November 1, 2022, the NATAS policy with respect to the Children's & Family Emmys® (the "Event") is that all attendees, including credentialed media and publicists must provide proof of either:

- (a) Full vaccination against the SARS-CoV-2 virus, including a single booster (if eligible); or
- (b) a negative result on a PCR-based molecular test that was administered no earlier than 72 hours prior to at the event.
- (c) All children/minors must also comply with this policy.

Attendees will also be required to complete a health survey on the day of the Event.

NO FACILITIES WILL BE PROVIDED FOR ONSITE TESTING FOR THOSE WHO FAIL TO MEET THESE CRITERIA UPON ARRIVAL.

Individuals who have tested positive for COVID-19 and are within days zero to five following their first positive test result may not attend the Event under any circumstances.

1. Individuals who have tested positive for COVID-19 and are within days six to ten following their first positive test result may only attend the Event upon providing proof of a subsequent negative PCR test taken no earlier than 24 hours prior to the arrival.
2. Individuals who have tested positive for COVID-19 and are more than ten days following their first positive test result, and are no longer experiencing symptoms, but continue to test positive on PCR tests may only attend the Event upon providing Documentation of Recovery signed by a Doctor or Health Department official stating the individual has met the CDC-recommended guidelines for isolation.

Any attendee who tests positive for COVID-19 within fourteen (14) days of departing the Event must immediately inform NATAS.

3. This policy is subject to change at any time prior to the NATAS Event.

We will be using the CLEAR® Health Pass to provide easy proof of required COVID-related health certification for faster entry to the event.

CLEAR® is widely used in the television industry for this process.

Please instruct your attendees to download the [CLEAR® Health Pass app](#) on their phone, if they haven't already. In the field "Have a code?" enter NATAS and then follow the instructions from that point on.

When in the app, after you have taken your picture you will and note that you are a NATAS Attendee, you will be given the choice to "Select Your Event." When you arrive at this screen, click on it and you will be given the choice of either:

12/11 - Children's & Family Emmys

Please Note: All attendees 17 years of age and less must be accompanied by an adult Parent / Legal Guardian. (Family members can represent siblings but otherwise each minor must be accompanied by a separate Parent/Legal Guardian.). All attendees over the age 5 and over must also be prepared to show proof of vaccination. Those between the ages of 14 and 17 can download the CLEAR app. Instructions for CLEAR for Minors is here...
